In the heart of the Swan Valley, nestled deep amongst the old vines and babbling brooks of the region lies our hidden gem known as Collector of Souls.

Legend has it that the original Distiller of Collector of Souls, known simply as "The Collector," had a unique gift for crafting spirits that seem to capture the essence of each patron's soul. With every sip of Holy Water Vodka, Gin Reaper Dry Gin, or Psychopomp Pink Gin, customers experienced a journey of flavours that stirred their deepest emotions and memories.

As word of mouth of the mystery Distiller's gift spread, the Collector of Souls Spirits range became a sanctuary for those seeking solace or inspiration. Artists found muse in the swirling colours of their drinks, while lovers whispered sweet nothings over glasses of alluring elixir. Even the most hardened souls couldn't help but be moved by an unexplainable magic.

Over time, the enigmatic venue, once known only for its ethereal spirits, has introduced a range of artisanal beers. Our Beelzebub Brewing Co (a devilish Collector of Souls himself, and famously referenced in Queens "Bohemian Rhapsody") is our in-house brewed beer line. complemented by our Galileo Figaro Ginger Beer, Scaramouche Apple Cider, Framboise Fandango Raspberry Seltzer and Old Soul Hard Lemon.

Each brew, carefully crafted by The Collector, carries the same mystique as the spirits, with flavours that spoke of forgotten dreams and untold stories.

Amidst the laughter and clinking glasses, there has always been an air of mystery surrounding the elusive Distiller. Some whispered that The Collector had made a deal with the devil to acquire his extraordinary talents, while others believed he was a guardian of lost souls, guiding them to redemption one drink at a time.

Regardless of the truth, one thing is certain: as long as there were souls in need of a drink, The Collector will be there, ready, pour in hand, to weave his magic once more.

Our venue offers the ideal casual function space, with an opulent chandelier lit indoor lounge, an outdoor beer garden shaded by an old lemon gum, and two bars for guests to access.

TERMS & CONDITIONS

Booking Information & Payments

Minimum Spend: All functions require a minimum spend on food & beverages of \$4000. Packages cover a 4 hour hire & service period. Please contact us for smaller bookings that do not require exclusive venue hire.

Venue Hire: Venue hire fees apply subject to food & beverage spend. Please contact us to discuss.

Deposit: A \$1000 deposit is required to secure your booking. Tentative bookings will be held for 7 days. The booking will be automatically cancelled unless a deposit has been made to secure your date or extend the tentative booking.

Final Payment: Final payment is due 10 working days prior to the function date. MasterCard, Visa & American Express Cards are accepted for payments and incur a 2.2% processing fee. Bank transfers will not incur a transaction fee.

Food & Beverage

Menu Selection: All details are to be finalised 14 days prior to your function date, this includes final numbers and dietary requirements. Should guest numbers be reduced on the day, you will be charged the fee as confirmed 14 days prior. Additional fees will apply of the equivalent to the full per person fee of your selected food package for increased guest numbers requested within 14 days of your function date or for alternate meal options requested by/for guests (i.e. differing from the final confirmation). All catering menus and items are subject to availability and subject to change. While every effort is made to provide the advertised meal options on the day of the event, menus cannot be guaranteed due to seasonal, yearly changes or unforeseen circumstances.

Beverage Conditions: All beverage menus and items are subject to availability and subject to change. While we endeavor to provide the advertised beverage options on the day of the event, menus cannot be guaranteed due to seasonal, yearly changes or unforeseen circumstances. The Organizer is not permitted to supply their own beverages, as this is an infringement of venue licensing regulations. Gifts of alcohol presented must remain sealed whilst on the premises. Beverages are available on a set package or consumption basis.

Venue Use

Inclusions: Your package fee includes service staff, set-up and pack down of your event, glassware, cutlery and crockery. Access to the venue will be permitted 1 hour prior to the event unless otherwise arranged. Collector of Souls reserves the right to change location of event to another suitable location within the venue or commence the venue closing process within the property after the 4 hour event package,

Decor: any decorations or equipment brought into the venue must be approved by Collector of Souls. All items must be removed at the end of the event unless prior arrangements have been made. Candles must be of high quality and used in conjunction with a candle jar/holder/base. Nothing is to be nailed, screwed, stapled or adhered to any wall, door or surface of the venue. Confetti, glitter, party poppers, synthetic flower petals, colored streamers and rice are not permitted anywhere within the buildings or grounds. Natural flower petals dried/fresh and leaves are accepted. Collector of Souls is always extremely careful when looking after patrons and their belongings, however the Company accepts no responsibility for the damage or loss of merchandise on our premises prior to, during or after your function. Any personal items not collected within 24 hours of the event will be disposed of, with a disposal fee charged if required.

Bond & Liability: The Organiser will be financially responsible for any damage to the property, function room facilities, equipment, fittings or surrounds caused by guests (including vendors) to Collector of Souls.

A credit card authorisation form is required to be completed upon booking for security of the property & equipment.

Weather: Collector of Souls recommends you contact your Function Coordinator to discuss possible options should the weather be inclement or unpredictable. We cannot guarantee undercover or an alternate location for events booked outside. Please note if you are booking an outdoor environment for your function, whilst every endeavour has been made to have tables in the shade or undercover, there may be occasions when guests are sitting in full sun or exposed to elements. Event will proceed rain, hail or shine. No rainchecks.

Live Music & Entertainment: Approval of live entertainment is based on application. Please contact the Function Coordinator via email before booking any bands or live entertainment. If approved, all live entertainment vendors are required to complete a compliance form to ensure understanding of relevant requirements and restrictions at Collector of Souls. This includes performance location, set-up and noise levels (i.e. bass, microphones). The compliance form must be submitted no later than 21 days prior to your Event. Please note all live entertainment must finish by 12:00am. If your supplied entertainment vendor (e.g. DJ, band) does not strictly adhere to the direction and compliance agreements of Collector of Souls and its management, entertainment will be replaced with our house music. Failure to comply with agreed terms will result in the event being terminated and the guests will be required to leave.

Postponement or Cancellation

Postponement: In some circumstances organisers may choose to postpone their event to a later date due to personal choices/reasons. A change of date is up to the discretion of Collector of Souls and will be dealt with on an individual basis. Bookings cannot be postponed within 14 days of the event date.

Cancellation: All cancellations must be received in writing to Collector of Souls. Please ensure you have received confirmation of your cancellation via email. All deposits are strictly non-refundable and the Organisers will not be entitled to any refund of the deposit. Bookings cancelled within 14 days of the event date will be charged the full event total.

Unforeseeable circumstances: Collector of Souls is not liable for any failure to perform its obligations due to events beyond its control, including but not limited to natural disasters, strikes, or government restrictions.
